The sample was run in scan mode on a GC/MS scanning from 35-500m/z. Any peaks found were tentatively identified by matching the mass spectra against the NIST 11, containing over 200,000 compounds and the SWGDRUG mass spectra databases, which incorporates over 3800 illicit and recreational drugs. The following two compounds were tentatively identified:
